Scottsville City Council convened December11, 2023 in the City Council room with Mayor David Burch presiding and all council members were present except Shane Blankenship. Special guest, Reverend G. J. Farmer of Scottsville Baptist Church, was requested to open the meeting with prayer. Rev. Framer has announced his family will be leaving Scottsville and returning to his home area in Somerset Ky.

Meeting minutes of November 27, 2023 were approved with no corrections or additions.

Chief Darren Tabor reported 1,052 calls for service during November. Wyatt Marr has been employed by the police department and will begin January 1 along with 20-week academy training.

Chief Tabor reviewed the council members on the Uptown Motel 30 day vacate order for all residents and the order will expire December 16. Anyone remaining on the property will then be involved in court eviction.

Johnson informed Shrum that he was not allowed to go to her home as he was not allowed to be around her youngest daughter because of a court order. Shrum went to Johnson's home anyway and Johnson called the police. That was when Shrum had thrown a weapon and broke Johnson's vehicle window. Johnson was able to provide a knife with a 17 and a half inch blade that she claimed Shrum had used.

when those who are lost are young in their life. For the Pearson family, dealing with the loss of their daughter Haley Sue led them to continue a legacy she had lived by loving and helping those around

Part of that comes in the form of hosting the "Merry Little Christmas" party, which they did on Saturday, Dec. 9 at the Washington Center

Haley Sue Pearson was born on Nov. 30, 1995 and Scottsville was her home for the first eight years of her life. "She loved Scottsville. This was her home. She actually wrote a paper when she was in college about going home, and it was to go to Scottsville," said Pam Pearson, the mother of Haley Sue. "She didn't want to go when we went. We went because of jobs, so in her mind this was home to her, and she loved to come home and see her family, her grandparents, her aunts and uncles because a lot of them were still here."

On Dec. 6, 2020, just days after her 25th birthday, Haley Sue went to go help a friend. However an accident claimed her life. It came as no surprise to her family and friends that she went to help a friend without hesitation.

Love was something that really defined Haley Sue's life. Her husband, Matt Hubert, said she was "just a light in every single room she walked in. I think the key to her and her soul was every single person who came into her presence was loved, and loved fiercely

and immediately. It didn't matter if it was children, like we're doing today, or her family or her friends. There's not a single person that's ever met her that wasn't changed for the better."

Christmas especially was important to Haley Sue, and it was her favorite holiday of the year. "She loved Christmas and she loved children. And so we wanted to come back here and do this where she loved to be and do the things that she loved to do. So that is to create a great Christmas, just like a good ol' Pearson Christmas, but in her honor with a bunch of kids that we invite to our event" said Pam Pearson.

In addition to the "Merry Little Christmas" party held in Scottsville, the Haley Sue Foundation is involved in other things as well. Founded in March of

Foundation has helped college students with scholarships. One is called a "Sibling Scholarship" which Stacy Pearson, Haley Sue's father, described as a scholarship "for those who have lost a brother or sister, and this year we're looking to expand that nationally." The other is available to those who have demonstrated a life like Haley Sue lived. While that one is available currently to Williamson County, Tenn., residents, they're looking to expand it nationally as well.

Beyond scholarships though is the investment in families and especially in women and children. Stacey Pearson added, "We're looking at families and women as well who are in hardship. Haley really started having a heart for those in women trafficking and child trafficking. We're just a small group try-
